**A PRATTVILLE CITY ORDINANCE PROHIBITS ALCOHOLIC BEVERAGES AT THIS EVENT.** All means of display must be provided by the vendor. Tables and chairs will not be provided. A cover should be brought in case of rain or extreme heat/cold. All extension cords must be taped or staked down. The City of Prattville will not assume responsibility for theft and/or damage. Fees are not refundable. Space is limited, only a limited number of applications will be accepted. Vendors are responsible for reporting and paying all sales taxes that are due and required. Booths/tents must be set up by 9:00 a.m. on Saturday and not dismantled until after 5:00 p.m. on that day. Vehicles must be removed from the area by 9:00 a.m. and may not re-enter the area until 5:15 p.m. **NO VENDORS WILL BE ALLOWED TO ENTER THE PARK AFTER 9:00 a.m.**

Only Pepsi/Buffalo Rock soft drinks, sports drinks, water and other beverages, whether from a fountain, bottled, or canned, may be sold at this event due to an existing contract. You may only prepare and sell the food approved by the Special Events Office. All food vendors must meet Health Department requirements.

Those applications accepted by the application committee will be sent space assignments, maps and other pertinent information after the application deadline of February 1, 2021.

**NO ELECTRICITY IS PROVIDED.** Only quiet generators will be allowed (less than 75 decibels).

## ACKNOWLEDGEMENT

I have read and understand the terms and conditions set forth in this application and agree to abide by them and such other rules and regulations as established by the City of Prattville.
