 3. Applications for signs at a height greater than 8 feet shall include foundation and structural details stamped/signed by an Alabama licensed civil engineer. Documents must be originals – no copies.
 4. Proposed signs with lighting or mechanical components must include electrical specifications. A separate electrical permit may be required.
 5. Additional information as needed for the specific installations
