ORDINANCE
INTRODUCED ON AUGUST 18, 2015

[To Zone Property Located at 630 Vintage Way to R-5 (Patio Garden Homes).]

BE IT ORDAINED by the City Council of the City of Prattville, Alabama, as follows:

THAT the Zoning ordinance of the City of Prattville, Alabama adopted on February 10, 1950, subsequently amended from time to time, and the zoning map adopted on the 1st day of May, 1987, is hereby amended to reclassify the property described in Attachment "A" and displayed in Attachment "B" R-5 (Patio Garden Homes); and

THAT this proposed Ordinance was advertised for two (2) weeks in the Prattville Progress, a newspaper of general circulation within the City Limits of the City of Prattville, and that the City Council of the City of Prattville, shall, at its Public Hearing on the 15th day of September, 2015 at 6:00 p.m., consider said proposed Ordinance and that at such time and place all persons who desire, shall have an opportunity to be heard in favor of or in opposition to such Ordinance.

THAT this Ordinance is adopted under the authority of §11-52-85 of the Code of Alabama, as amended and is contingent on the petitioner completing the process to annex property described in Attachment A and shown in Attachment B into the City of Prattville no later than 180 days following adoption of the Ordinance.

ALL other items and provisions of the Zoning Ordinance of the City of Prattville not herein specifically amended shall remain in full force and effect.

THE amendments herein contained were considered and approved by the City of Prattville Planning Commission on July 16, 2015.

THIS Ordinance shall become effective upon its passage and execution as provided by law.
